PRESIDENT'S REPORT

Paul presented his report.

- 2023 has been a period of consolidation after Covid
- Reduced membership base (27% drop in last 4 years)
- Playing numbers are down about 30% since 2019 (true across W/Bays and NZ)
- Hope for better retention going forward with recruitment of new players being a drive for 2024. Kim Grounds attended a conference in Christchurch. Cambridge is to

- participate in a Facebook page in January to attract younger players to lessons starting in February. Daytime and evening lessons to run concurrently.
- Money-wise the Club remains steady. 2023 brought big expenditure on roof repairs, new dealing machine and printer.
- Treasurer will be calling for increased subscriptions which have not changed in ten years. Table money remains unchanged. New committee will discuss the series prizes which currently cost the club about \$3,000 per year.
- Waipa lease of Club ground expired in September. Club was approached by Council
 to renew the lease some months ago. Our signed copy is yet to be signed and
 returned by Council. President suspects the site is being looked at as a possible
 library site but this would be several years down the track.
- Bridge game. All series were completed with no Covid disruptions.
- Tournaments. Both Junior and Intermediate were hosted this year.
- Fairlands Trophy against Te Awamutu resulted in a Cambridge win.
- Sixes. Very successful event requiring fair amount of work. Paul thanked Bill Robinson (floor manager), Jan Spaans (scoring and boards), Ailsa (kitchen), Bev (raffles), Clare (Master of Ceremonies). He also acknowledged the help of neighbouring clubs with the loan of equipment and a special thank you to AFT for their sponsorship.
- Charity for 2023 Police Blue Light.
- Thank you to many in the club for improver lessons, beginner lessons, dealing, scoring, the partnership stewards. Thanks to Bill for maintenance, Anna and Barb for kitchen supplies, Vicki our computer manager and Programme book organizer, Michael for dealing issues, laptop issues and resolving no power by suggesting play be by the light of mobile phones. Thank you to Nandy for the WhatsApp initiative, lan for supporting players on Friday mornings, Bruce Hall our Honorary Auditor, and the committee for their work. Barb, Bev, Mary and Ailsa are stepping down this year. Thank you to lan, Club Captain for his work.
- Welcome to Kim, Sue, Nandy and Sam who are coming onto the 2024 committee.
- Amended Act for governance of Incorporated Societies requires the club to look at its constitution and to re- register under this Act by April 2025.

Ian Moore acknowledged Paul's outstanding work as President over the past year.

TREASURER'S REPORT

Kevin Whyte presented his report. Bruce Hall audited the Club's Financials in accordance with the Review Engagement Standards issued by the NZICA. The finances showed a surplus of \$8,458 before depreciation and \$3,357 after depreciation. This net surplus just about balances the deficit of \$3,379 from 2022.

If one takes the cleaning cost, power, insurance and R&M (all "fixed" costs) plus the increased fees payable to NZ Bridge, it is necessary to increase the annual subscription to \$60 per year. By comparison Balclutha pay \$55, and other comparative clubs, \$60, \$80, \$77, and \$107 in subscriptions each year.

Resolved: That the annual subscription be increased from \$45 to \$60 per year for full time members, and from \$27 to \$35 per year for associate members
